### DESCRIPTION OF FIRST AID MEASURES

#### GENERAL ADVICE

HYDROFLUORIC (HF) ACID BURNS REQUIRE IMMEDIATE AND SPECIALIZED FIRST AID AND MEDICAL TREATMENT. SYMPTOMS MAY BE DELAYED UP TO 24 HOURS DEPENDING ON THE CONCENTRATION OF HF. ABSORPTION CAN READILY OCCUR THROUGH THE SUBUNGUAL AREAS AND SHOULD BE CONSIDERED WHEN UNDERGOING DECONTAMINATION.
